4. Narrative: I SPOKE WITH RUBEN BLAKELY AGAIN TODAY IN REFERENCE TO A NOTE I MADE ABOUT HIM TELLING ME ABOUT AN INCIDENT ON 100CT95 THAT I DID NOT ENTER IN THE CASE UNTIL NOW.

THE INCIDENT WAS ON 100CT95 AT APPROXIMATELY 1930 HRS. AFTER EVERYONE IN BOTH FAMLIES HAD LEFT THE CRIME SCENE AND THEY HAD WENT TO RUEBENS HOME. TED AND RONNIE WERE TOGETHER AND HAD BEEN TALKING FOR A SHORT WHILE AND AT APPROXIMATELY 1930 HRS. TED CAME TO HIM AND WANTED TO BORROW A FLASHLIGHT AND RUBEN ASKED HIM WHAT HE WANTED A FLASHLIGHT FOR. TED TOLD HIM THAT HE AND RONNIE WANTED TO GO TO LYLES BUILDING MATERIAL AND LOOK FOR SOME EMPLOYEE RECORDS THAT THEY MIGHT BE SUSPECTS. RUEBEN GOT HIM A FLASHLIGHT AND TED AND RONNIE LEFT. IN REFERENCE TO RONNIE, I AM SPEAKING OF RONNIE HIS BROTHER, NOT RONNIE HIS FATHER.

RUEBEN SAID-THAT THEY RETURNED ABOUT TWO HOURS LATER BUT NEVER GAVE HIM HIS FLASHLIGHT BACK AND IN FACT HAS NOT GOTTEN IT BACK AS OF YET. RUEBEN DIDN'T ASK TED OR RONNIE ANY QUESTIONS ABOUT WHAT THEY GOT AT LYLES THAT NIGHT.

THL NEXT DAY 110CT96 RUBEN TED AND OTHERS WERE TOGETHER AND TALKING AND AGAIN TED MADE THE COMMENT THAT HE HAD TO GO TO LYLES BUILDING MATERIALS AND GET INFORMATION ABOUT EMPLOYEES FOR SUSPECT REASONS. RUBBEN TOLD TED THAT HE THOUGHT THAT THAT WAS WHAT HE DID THE NIGHT BEFORE WHEN HE BORROWED HIS FLASHLIGHT AND TED REPLIED THAT NO, I DIDN'T GO TO LYLES LAST NIGHT, I DIDN'T HAVE TIME. RUBBEN DIDN'T INQUIRE AS TO WHY THEY DIDN'T GO TO LYLES THE NIGHT BEFORE OR WHERE THEY DID GO FOR THE TWO HOURS THEY WERE GONE AND NEEDED A FLASHLIGHT.
