- Narrative: I SPOKE WITH VALLEY BLAKLEY BY PHONE TODAY 12NOV95 AT VALLEY SAID THAT TED CALLED HER AND WANTED TO TALK TO HER AND 1530 HRS. THAT SHE WENT BY LYLES JUST TO SEE WHAT HE WANTED. SHE SAID THAT TED TOLD HER THAT HE HAD BOUGHT SOME LAND ACROSS FROM THE FOOD-RITE IN CLIMAX AND WAS GOING TO BUILD A GARAGE WITH LIVING QUARTERS ABOVE IT AND LIVE IN IT WHILE HE BUILT HIS NEW HOUSE. HE TOLD HER THAT HE WAS TIRED OF PEOPLE COMMING UP TO HIM AND ASKING HIM ABOUT PATRICIA AND HOW HE WAS DOING SINCE SHE DIED AND THAT HE WANTED THE INVESTIGATORS TO LET HIM ALONE. SAID HE WANTED ME, THIS WRITER, TO LET HIM ALONE, THAT I WAS TO NOSIEY AND HE DIDN'T LIKE ME INVESTIGATING HIM. SHE SAID THAT HE SHOWED HER HIS MOTORCYCLE AND ASKED HER IF SHE WOULD GO OUT TO A MOVIE WITH HIM AND THAT GOING TO THE MOVIE WAS NOT BECAUSE OF JUST BEING A FRIEND BUT THAT SHE THOUGHT HE MENT FOR OTHER THINGS OTHER THAN A MOVIE. SHE SAID SHE WAS GLAD TO SEE ME COME IN AND THAT WHEN I LEFT SHE TOLD HIM SHE HAD TO GO AND THAT SHE LEFT AND DID NOT GIVE HIM AN ANSWER ABOUT GOING TO THE MOVIE.
 VALLEY SAID THAT SHE THOUGHT TED WAS THE PERSON WHO MURDERED PATRICIA AND THAT SHE WAS SURE THAT HE WAS CAPABLE OF DOING SOMETHING LIKE THAT USE OF HIM HOLDING A PISTOL TO JOY DRYERS HEAD AND TELLING HER THAT HAD BETTER GET AN ABORTION WHEN HIS BROTHER RONNIE GOT HER PREGNANT. I ASKED VALLEY HOW SHE THOUGHT TED COULD HAVE BEEN AT HIS HOUSE TO MURDER PATRICIA WHEN HE WAS AT LYLES AND LEFT THERE AND WENT TO HIS SECOND JOB. VALLEY ANSWER WAS, WHO SAID HE WAS THERE AND WHO SEEN HIM THERE, HE NEVER DID STAY THERE MUCH IN THE PAST, HE WAS ALWAYS OUT RUNNING AROUND.
- I ASKED HER WHY SHE THOUGHT TED KILLED PATRICIA AND SHE SAID THIS::: TED DIDN'T LOVE PATRICIA.
- TED TOLD HER SISTER KRISTINA THAT HE STILL LOVED JANET HER OTHER SISTER AND THIS WAS AFTER TED AND PATRICIA WERE MARRIED.
- SHE SAID PATRICIA WASN'T IN TEDS PLANS OR BLUEPRINTS.
- PATRICIA WAS IN THE WAY OF WHAT TED WANTED TO DO AND THE WAY HE WANTED TO LIVE.
- SHE SAID TED WAS JUST SITTING AROUND WAITING ON THE INSURANCE MONEY SO HE COULD GET ON WITH WHAT HE WANTED TO DO.
- SHE SAID TED WAS JUST USEING PATRICIA AND THAT IT WAS PLAIN TO SEE IN HER OPINION.
- I ASKED HER IF SHE KNEW RONNIE, TEDS BROTHER, AND SHE SAID YES AND THAT RONNIE WASN'T RIGHT OR NOT ALL THERE AND THAT RONNIE COULD HAVE BEEN TALKED INTO KILLING PATRICIA BECAUSE OF TED HELPING RONNIE WHEN HE GOT JOY PREGNANT AND HOLDING A GUN TO JOYS HEAD.

VALLEY SAID THAT IF TED CONTACTED HER AGAIN THAT SHE WOULD CALL AND LET
