I DROVE TO JAMES DAYS HOUSE ON 19DEC95 AND SPOKE WITH HIM IN PERSON. JAMES SAID HE FIRST MET TED KIMBLE THROUGH ANISSA HEDGECOCK, WHO WAS HIS, JAMES, GIRLFRIEND AT THE TIME. THIS INTRODUCTION WAS IN 1989. JAMES AND TED BECAME FRIENDS AND WERE ROOM MATES FOR ONE AND ONE HALF YEARS. JAMES SAID THAT THEY RENTED A MOBILE HOME ON HEMPHILL ROAD FROM A MR CAPPS.

JAMES STATED THAT ANISSA HEDGECOCK WAS NOT EITHER OF THE HEDGECOCK GIRLS THAT TED AND RONNIE KIMBLE DATED. THEIR NAMES WERE FAITH AND JOY HEDGECOCK. JAMES SAID THAT WHAT HE KNEW ABOUT THE HEDGECOCK SISTERS THAT TED AND RONNIE DATED WAS THAT HIS UNDERSTANDING WAS THAT JOY BECAME PREGNANT TWICE, ONCE BY TED AND ONCE BY RONNIE.

JAMES STATED THAT IN 1989 TED HAD A CONQUEST CAR AND HAD A WRECK IN SAME AND THAT TED HAD TO GET A LAWYER BEFORE THE INSURANCE COMPANY WOULD PAY. JAMES FURTHER STATED THAT TED WRECKED THE SAME CAR A SECOND TIME AND COLLECTED FULL INSURANCE FOR A SECOND TIME. TED THEN BOUGHT A NEW 1990 ISISU PICKYP TRUCK FROM GREEN FORD IN GREENSBORO. JAMES SAID THAT TED PUT A STERO SYSTEM IN THE ISISU TRUCK AND THAT NOT LONG AFTERWARDS THE STERO SYSTEM WAS STOLEN ACCORDING TO TED AND THAT TED COLLECTED FROM THE INSURANCE COMPANY ON THIS ALSO.

JAMES SAID THAT APPROXIMATELY ONE AND ONE HALF YEARS AGO HE JOINED THE SOUTH ELM BAPTIST CHURCH WHERE TED ATTENDED AND AROUND THAT TIME TED WAS WITH HIM IN HIS VEHICLE WHEN AN ACCIDENT OCCURRED. THIS ACCIDENT RESULTED IN TED COLLECTING INSURANCE MONEY FOR NECK INJURIES. THIS ACCIDENT WAS THE OTHER DRIVERS FAULT ACCORDING TO JAMES.

JAMES STATED THAT TED WAS ENGAGED TO JANET BLAKLEY IN 1993 AND ALL WAS FINE AS FAR AS HE KNEW AND THEN WITHIN THIRTY DAYS TED WAS ENGAGED TO PATRICIA AND MARRIED NOT LONG AFTERWARDS.

JAMES SAID HE WAS NOTIFIED ON TED AND PATRICIAS HOUSE FIRE AND SAW SAME ON TELEVISION AND DROVE TO GREENSBORO TO THE CHURCH AND DID GO BY REV. KIMBLES HOUSE TO SEE TED ON THE SAME NIGHT OF THE HOUSE FIRE.

JAMES DID NOT INDICATE WHO HE THOUGHT MIGHT HAVE KILLED PATRICIA OR SET THE HOUSE ON FIRE, BUT DID SAY THAT HE WAS DRIVING BY THEIR RESIDENCE THAT DAY AND THOUGHT ABOUT STOPPING TO SEE IF THEY WERE HOME AND SPEAK WITH THEM BUT DECIDED NOT TO AND CONTINUED ON TO THE HOME OF A PERSON WHO HAD HAD A DEATH IN THE FAMILY TO VISIT WITH THEM.
