mrs. whidden had you met ronnie and kim kimble before that night of jan. 24 97 they called your house earlier correct first night you did not go out to dinner, they came in late where did they sleep where did your children sleep they indicated to you that ronnie had been in va being checked out for his sleep disorder they took you folks out to dinner your children came with you after dinner went to a shooping ctr. recall looking at some shoes with kim recall buying a chair at brendle's recall that kim and ronnie bought one to recall that you went home and ronnie helped mitch put the chair together [you do recall getting an office chair at a close-out sale do you recall after you ate going shopping and mitch debating whether or not to get a karoke recorder for his ministry at some point mitch and ronnie went upstairs for devotionals correct and that was when you became dizzy andpassed out do you recall ronnie carrying you upstairs this statement that you say ronnie made inthe car on the way home abt. having a haunted past, that was in front of you and mitch his wife and the children you told him that he hadn't done anything that the rest of us hadn't done [and his response was "I wouldn't be so sure." you didn't think anything abt. that response at the time you thought he was just maming light of the situation according to you the next thing ronnie said was that he needed to talk to mitch when you and kim were not around and did you think anything there was anything unusual abt. that statement at the time it was made

but in retrospect according to what your husband has told the jury, he was in effect announcing to all of you that he was going to confess to mitch as soon as you folks got home [your testimony is that he did say he needed to talk to mitch with you and kim not present as soon as you got home

you don't really remember much of what happened that night because you passed out

when you got up that morning, had ronnie and kim already left
you asked mitch if ronnie was coming to liberty

mitch told you he didn't think he would and he didn't want to talk abt. it

mitch didn't say anything more abt. it to you at all but later on you went to mitch and said ronnie killed his sister in law didn't he mitch hadn't said anything abt. the subject since he told yiou he didn't want to talk abt it but you still knew that ronnie had confessed to mitch [well what was it thaat mitch told you that made you come to that conclusion—specifics [you didn't put that donw in your statement that you made for det. church

the next tuesday on the 28th of january you and mitch went down to camp lejeune now you remember that you were the one that called ronnie as soon as you got down to lejeune how many times had you seen ronnie before that weekend up at your house and yet you were the one who called ronnie on base

\*CROSS ON RODNEY WOODBERYY you talked to detectives on a number of occasions first you told detectives that you didn't know anything suspicious concerning ted's activities

and you signed an affidavit on march 21, 1996 concerning what you knew abt. patricia's death

you read over that affidavit and checked it for accuracy in fact you made a number of changes on items that were not accurate

then you swore everything in that affidavit was true

among other things you sore the following was true: [read highlighted portions

but after giving that statement you agreed to make a taped call to ted for detective church

and you tried to get ted to admit that he said the things you are now claiming he said he denied all that said he didn't know what yu were talking about you talked to church and pendergrass abt. What to say to ted to get him to trust you that they were trying to put this thing on you

in your affidavit you signed you made it point to write out in your own handwriting that on the day patricia died you were at your house in graham and you also wrote out in your handwriting that at 6:30 p.m. you went to fill out a job application

did you have something to do with patricia's death do you know a woman by the name of laura shepard do you remember telling her on april 5, 96 when she came into the rrom after you woke her up because you were crying and when she asked you why you were crying you asked her to promise that she would come to visit you in prison that you told her you had done something that could get you the death penalty then you told her that you would be coming into some money soon and you would provide her with money while you were in prison
