4. Narrative: I SPOKE WITH CARA DUDLEY ON 10OCT95 1630 HRS. BY PHONE. CARA IS THE CRIMESTOPPER WHO CALLED ABOUT THE INSURANCE MONEY THE DAY AFTER PATRICIAS DEATH AND TOLD ME THAT PATRICIA HAD CALLED HER AND TOLD HER THAT TED HAD TOOK A LARGE INSURANCE POLICY AND THAT IF ANYTHING HAPPENED TO HER THAT SHE WANTED SOMEONE TO KNOW THAT TED HAD TAKEN THE INSURANCE POLICY. CARA AND PATRICIA WERE VERY GOOD FRIENDS AND WENT TO CHURCH TOGETHER.

CARA TOLD ME THAT PATRICIA TOLD HER THAT TED WANTED A MOTORCYCLE TO CRUISE HIGHPOINT ROAD. AND A FRIEND WAS SUPPOSED TO HAVE SEEN TED AT RHODES-FURNITURE SHOPPING TWO HOURS AFTER THE SERVICES AT THE CHURCH ON 14OCT95. SHE SAID THAT PATRICIA DID NOT WANT HIM TO HAVE A MOTORCYCLE. SHE SAID THAT PATRICIA WAS WITH HIM AT LYLES WHEN SOMEONE CAME IN AND OFFERED STERO EQUIPMENT FOR \$300.00 AND WAS TO MEET HIM AT CIRCUIT CITY AND PATRICIA TOLD TED NOT TO BUY THE EQUIPMENT AND NOT TO GIVE ANYONE ANY MONEY BUT TED SENT A BOY THAT WORKED FOR HIM TO CIRCUIT CITY WITH \$300.00 AND GOT RIPPED OFF.

SHE SAID THAT TED WAS ALWAYS BUYING THINGS AGAINST PATS WISHES. SHE SAID THAT SHE DID NOT KNOW ANYONE THAT WOULD HAVE ANYTHING AGAINST PATRICIA.

CARA SAID THAT WHEN THIS CONVERSATION ABOUT THE INSURANCE POLICY TOOK PLACE THAT PATRICIA WAS CALLING FROM HER HOUSE AND THAT TED MUST HAVE PAID CASH FOR THE POLICY BECAUSE THERE WAS NO CHECK WRITTEN AND THAT PATRICIA WAS VERY UPSET ABOUT TED BUYING THE INSURANCE ON HER WITHOUT HER PERMISSION OR EVEN CONSULTING HER. PATRICIA HAD TOLD TED THAT SHE DID NOT NEED INSURANCE THAT TED HAD ENOUGH INSURANCE ON HER ALREADY TO PAY EVERYTHING OFF AND HAVE \$30,000.00 LEFT OVER.

SHE SAID THAT PATRICIA TOLD HER THAT TED HAD TO HAVE THE BEST OF EVERYTHING AND ALWAYS WANTED TO MAKE HIMSELF LOOK GOOD. AN EXAMPLE SHE GAVE WAS THAT TED HAD TO HAVE \$4,000.00 IN OPTIONS ON THE NEW JEEP. PATRICIA ALSO TOLD CARA THAT TED HAD TOLD HER THAT HE WANTED TO GO OUT WITH PATRICK PARDEE AND PATRICIAS TWO COUSINS, JANET BLAKLEYS SISTERS, WITHOUT PATRICIA ALONG. >>>>CARA SAID THAT PATRICIA WAS JUST TOO GOOD FOR TED<<<<<<.

A - Cara Dudley - married David Dudley. After doing so had very little to do with Patricia because her husband is so possessive and over bearing. After her first child she must have put on a 100lbs and kept it. Patricia claim to hardly ever speak with her. Cara is a home busy body.

B - I'd already had two motorcycles and wanted another the day after taking the last. It wasn't to leave Patricia at home either.

C - I spent the day with my family. "More Gossip"

D - It wasn't 300⁰⁰, it was more like 700⁰⁰? See back of page 33 under B - Robert Tidwell

E - I bought things for a living. It's my job. Anything personal Patricia and I discussed it. Sometime less than she liked.

F - Not True by a long shot

G - More gossip, Cara's now putting words in Patricia's mouth.

H - Patricia and I had argued over which model 26F Grand Cherokee or 28F "Big Deal"

I - Had nothing to do with Janet Blakley. This was approx 6 months before Patricia's Death. Patric Pardee was heading to "Blues" on after noon and taking Krissy and Vally Janet's 13 & 15 year old sisters and wanted to know if I wanted to go. Patric owned 2 sea doos. It would only be a few hours. I ask Patricia if she minded and she got up-set so I didn't go. Patricia was very jealous.
