I RESPONDED TO A HOUSE FIRE ON BRANDON STATION CT, PLEASANT GARDEN ON AY AFTERNOON AROUND 8:45 P.M. WITH THE PLEASANT GARDEN FIRE L ATMENT, WHERE I WORK AS A VOLUNTEER FIREMAN.
