Administrative Responsibilities: Director Psychology Department, Beaufort Naval Hospital Command and Director Alcohol Rehabilitation Department, Beaufort Naval Hospital Command: (October 1986 - August 1988) (given Navy Achievement Medal and Promotion)

In these positions, I was responsible for the staff, programs and fiscal operation of the psychology departments located on Parris Island Marine Corps Recruit Depot, Marine Corps Air Station, Beaufort and Naval Hospital, Beaufort as well as the inpatient services offered by the drug and alcohol rehabilitation unit. I was responsible for the supervision of five alcohol counselors, one alcohol counselor/program director, four ARS corpsmen, one RN, one doctoral level physician, and one ARS secretary. On the psychology department side of the house, I was responsible for three psychology department corpsmen, eight marital and family therapists and two doctoral level psychologists. Supervision of staff was both clinical and administrative in nature. Under the psychology department there was a post-doctoral clinical psychology residency program which I directed. There was also responsibility for the supervision of fourth year medical students on rotating externships. The psychology department was responsible for reviewing and approving all research within the BNH Command. I chaired this committee. During officer of the day duty, there was a total administrative responsibility for the functioning of BNH (24 hour on board duty).

Clinical Responsibilities: Consultation to all medical specialties within BNH (i.e., surgery, internal med., ortho., peds., E.R., Derm., optometry/ophthalmology, anesthesiology, family practice/General Medicine, oral surgery/ dentistry, etc.). The age range was from two years to geriatrics. There was also a large retiree population in the naval Hospital Beaufort catchment area (age 60-up). Duties included crises intervention, family therapy, behavioral medicine, biofeedback, hypnotherapy, behavior modification, group psychotherapy (in both NPU dept. and ARS). I performed

perceptual/motor, neuropsychological, personality, intellectual, educational diagnostics on all ages. Workshops/clinics on weight reduction, stop smoking, and stress management. 24 hour psychology/psychiatry watch through the ER BNH. During psychology/psychiatry watch responsibilities included emergency intervention and disposition of patients seen in the Beaufort Naval Hospital catchment area (usually seen in ER -BNH, but often in the field at Parris Island Clinic or MCAS Clinic Beaufort). This was a very active on call. Member of Specialized Psychological Rapid Intervention Team (SPRIT) which provided immediate intervention with commands in the event of disasters. Psychologists fought for and gained full admission and discharge privileges while I was director of the Psychology Department.

Administrative Responsibilities: General supervision of enlisted personnel, junior officers assigned to duty at MCRD, Branch Clinic, Parris Island. this included nurses, psychiatric technicians, secretaries, scribes, hospital administrators, etc. Supervision of staff was both clinical and administrative in nature. Drug and alcohol subcommittee on centralizing services at Naval Hospital, Beaufort. Supervision of group therapy program at Parris Island (which was carried out through D&A, Brig, Family Service Center, Religious Ministries Center and Fitness Center).

Clinical Responsibilities: Consulted to the Family Services Center, MCRD, P.I. (1/2 day per week) and to the Alcohol Rehabilitation Service, Naval Hospital, Beaufort, S.C. (1/2 day per week); screened all applicants for Drill Instructor School for psychological problems; assessed Marine Recruits (17-22 year olds) referred to the Neuropsychiatric Unit, Branch Clinic, Parris Island. S.C. Crisis Intervention with recruits, Navy and Marine permanent party personnel. Brig. The age range of those treated spanned the gamut from age 4 to age 70+. The population was military families and retired military and their families. Consulted to the law centers at MCAS, Beaufort and MCRD, Parris Island. Frequent court appearances as an expert witness. Psychodiagnostic assessments (i.e., cognitive, perceptual, personality, educational, vocational, and neurological). Stress management workshops for drill instructors and their families. Workshops on how to stop smoking and weight reduction for permanent party personnel and their families. Clinical consultation to various medical disciplines, schools physical therapists, psychiatric social workers, nurses, etc. Supervision of psychiatric social work interns. There was involvement in 24 hour crisis call of MCRD, P.I., and the emergency room, Beaufort Naval Hospital as well as 24 hour administrative call (officer of the day). During "on call" days, there was responsibility for clinical coverage in the emergency room and responsibility for administrative functioning of the Naval Hospital, Beaufort, as a whole. I was also military representative to the Low Country Family Planning Council. Consultation to Brig I ran a group for prisoners and a weekly group for Brig guards.

Clinical aspects of the supervision involved various forms of psychotherapy, hypnotherapy, psychological testing and consultation. Administrative supervision for the children and youth team members was concerned with ensuring that the workload was evenly distributed, and establishing equal distributions of "on call" duties. Responsible for the hiring of new staff members and disciplining of inadequate staff performance. Inservice staff training, directing staff meetings and case conferences were also among my responsibilities. Responsible for overall programming, growth and evaluation of the Children and Youth Program and Psychology Dept. This included setting priorities, goals, personnel decisions and obtaining materials for both the Psychology Department and the Children's Services. Responsible for budget preparation in conjunction with the Accounting/Fiscal Control Department. Also responsible to see that policies, procedures and work standards of the Mental Health Center were followed, and overseeing contracted services for the entire Mental Health Center. Responsible for the functioning of an Early Intervention Program.
