4. Narrative: I SPOKE WITH JEFF GUYER BY PHONE ON 28NOV95 AT HIS HOME, 685-0780. JEFF STATED THAT HE IS A FORMER POLICE INVESTIGATOR FROM NEW MEXICO AND HAS MOVED TO NORTH CAROLINA AND IS RENTING GARY LYLES HOUSE ON HEMPHILL ROAD.

JEFF SAID THAT HE HAS BEEN TO LYLES BUILDING AND PAID HIS RENT TO TED WHO IN RETURN GAVE IT TO GARY LYLES, BUT RECENTLY HAS JUST BEEN MAILING IT TO GARY OR GIVING IT TO HIM WHEN HE IS IN TOWN.

HE SAID THAT ON ONE OCCASION THAT HE WAS TALKING TO HIS NEIGHBOR MR CAPPS AND MR CAPPS SAID THAT HE BUILT THE DOG HOUSES THAT TED SOLD AT LYLES AND THAT THEY WERE DISCUSSING PAYMENT OF THE DOG HOUSES AND DISCUSSING MONEY AND THAT TED BECAME VERY VIOLENT AND MR CAPPS HAD TO PICK UP A CHAIR AND DRAW IT BACK AND TELL TED HE NEEDED TO SIT DOWN AND GET HOLD OF HIMSELF. MR CAPPS ALSO TOLD HIM THAT ON ONE OCCASION THAT GARYS WIFE TOLD HIM THAT SHE WANTED TO TALK TO GARY AND THAT IF HE SAW HIM AT LYLES TO TELL THE SON OF A BITCH TO CALL HER THAT SHE WAS GOING TO MOVE AND THAT NOT LONG AFTER THAT THEY MOVED TO THE COAST.

JL SAID THAT GARY TOLD HIM THAT HE WANTED HIM TO SAY HE WAS RENTING THE HOUSE WITH AN OPTION TO BUY SO HE WOULDN'T HAVE TO PAY TAXES OR AS MUCH TAXES BUT GARY WOULD NOT DO IT.

HE SAID THAT GARY LEFT A BED WHEN HE MOVED AND SAID THAT IT WAS TEDS BED AND THAT HE HAD CALLED TED SEVERAL TIMES TRYING TO GET TED TO COME GET THE BED BUT TED KEPT PUTTING HIM OFF. SO ONE EVENING HE CALLED TED AND SAID THAT HE REALLY NEEDED TO COME GET THE BED AND TED SAID THAT HE COULDN'T AT THAT TIME AND LATER THAT NIGHT TED CALLED HIM AND SAID THAT THEY HAD JUST RE-DECORATED A ROOM IN HIS HOUSE AND WANTED TO COME GET THE BED THEN. JEFF TOLD HIM THAT HE WAS IN BED AT THAT TIME BUT TED INSISTED ON COMING AND GETTING THE BED THEN, THAT NIGHT. JEFF DON'T THINK TED PUT THE BED IN HIS HOUSE AND THINKS THAT TED WAS SEEING ANOTHER WOMEN AND NEEDED THE BED FOR HER. JEFF DESCRIBED THE BED AS A METAL FRAME WITH NO HEADBOARD, MATTRESS AND BOX SPRINGS. IT MIGHT BE NOTED THAT THERE WAS NO SUCH BED IN TED AND PARTICIAS HOUSE AT THE TIME OF HER MURDER.

THE SAME NIGHT TED PICKED UP THE BED AND WAS IN JEFFS HOUSE TED STARTED TELLING JEFF ABOUT HOW HE WAS CHANGING HIS INSURANCE ON HIM AND PATRICIA AND THAT THIS JUST CAME OUT OF THE BLUE AND THAT HE DIDN'T EVEN CARE ABOUT TED OR HIS INSURANCE, BUT NOW IT LOOK SUSPICIOUS THAT TED WOULD COME OUT WITH STATEMENTS ABOUT CHANGING HIS INSURANCE TO HIM.

HE SAID THAT GARY LYLES ALWAYS STAYED AT TEDS HOUSE WHEN HE WAS IN TOWN. HE SAID THAT GARY WAS IN TOWN LAST WEEK AND THAT GARY TOLD HIM SEVERAL TIMES THAT HE WAS IN TOWN ON THE 20TH AND THAT HE HAD TO BE BUT DID NOT GIVE A REASON, THAT WOULD BE 20NOV95. HE SAID THAT GARY WENT INTO THIS JOB TALE ABOUT HOW HE LOVED HIS WIFE AND ACTED VERY STRANGE. HE SAID THAT WHEN HE PAID GARY THE RENT FOR NOVEMBER THAT GARY ACTED LIKE IT WAS

→ This guys wife left him. Jeff skip town owing Gary money, Gary was just glad to get him out!

A- Jeff is a nut case and will most likely never take the stand. He made this up as he went. I'm not even sure if anyone knows where he is.

B- I look to Ed as a grandfather. The man died last year.

Ed's health was so poor he couldn't pick a chair up if he wanted to. I rented a trailer from Ed, behind Ed's house for 2 years. I was 19-20 years old. Ed quit building log houses for Lyles years ago because of his health and his wife. Ed cut his fingers off twice and she said that's it. "I loved the man"

C- I sometimes believe Gary retired more because Rose was pushing him to. She wanted to move to the beach. She takes "A LOT" of drugs for back problem. I use to go pick her medicine up "all the time." She eats pills like chicken feed. Gary may have retired but he's still working. He'll never stop, he's a second father to me.

D- I spent hours remodeling the first bedroom. Cherry rail, paint etc I spent even more time refinishing the furniture for the room. I stripped it and pickled it.

E- I called him between 7 or 8 o'clock and he wanted the bed out of his way. Gary was giving it to me if I recall but it wasn't mine.

F- He didn't describe it correctly

G- Never happened. He met me in front of the house and already had the mattress in the yard

SURVIVAL MONEY AND THAT HE NEEDED MONEY BADLY, NOW.

JEFF SAID THAT ON THE NEXT DAY AFTER PATRICIAS DEATH THAT HE CALLED
LYLES BUILDING MATERIAL, 10OCT95, AROUND 0930-1000 HRS AND GARY ANSWERED
THE PHONE AND HE SPOKE WITH GARY AND TOLD HIM TO TELL HIM THAT IT WASN'T
WHAT HE HAD HEARD ABOUT PATRICIA AND GARY TOLD HIM THAT IT WAS TRUE
AND TOLD HIM THAT HE WASN'T IN TOWN WHEN IT HAPPENED, BUT JEFF SAID HE
WOULD HAVE SWORN THAT HE SAW GARYS TRUCK COMMING ONTO THE RAMP ON HWY 62
ON THE EVENING OF 09OCT95 AT ABOUT 1930 HRS. AND WOULD HAVE BEEN COMMING
FROM PLEASANT GARDEN SOUTH ON HWY421

JEFF ASKED GARY ABOUT BEING IN TOWN ON THE NIGHT OF PATRICIAS DEATH AND
TOLD GARY THAT HE THOUGHT HE HAD TOLD HIM THAT HE WAS IN TOWN AND GARY
TOLD HIM THAT HE WASN'T THAT HE CAME UP THE NEXT MORNING.

JEFF SAID THAT WITH HIS EXPIERENCE IN LAW ENFORCEMENT THAT HE DOES NOT
THINK TED OR GARYS STORIES ARE UP TO PAR AND ALSO THINKS THAT THEY
PROBABLY KNOW MORE THAN THEY ARE TELLING.
