TOMMY STATED THAT HIS COMPANY HAS NOT PAID ANY CLAIMS ON THE LIFE INSURANCE THAT PATRICIA HAD AS OF YET, BUT THAT IT MAY COME A TIME THAT THEY HAVE TO PAY.
