4. Narrative: ON 10JUNE96 AT 1955 HRS. I SPOKE WITH KIMBERLY STUMP KIMBLE AT HER PARENTS HOME AT 5313 COBLE CHURCH ROAD, JULIAN, N.C. KIMBERLY IS THE WIFE OF RONNIE KIMBLE WHO IS IN THE MARINE CORPS AND STATIONED AT CAMP LEJEUNE, N.C. KIMBERLY HAS LIVED WITH HER PARENTS SINCE THE DEATH OF PATRICIA KIMBLE. SHE AND RONNIE LIVE AT 5821 MONNETT ROAD, JULIAN, N.C. AND WHEN HE COMES HOME ON THE WEEKENDS THEY GO TO THEIR HOME AND STAY UNTIL HE LEAVES FOR CAMP LEJEUNE ON SUNDAYS OR MONDAYS.

I ASKED KIMBERLY IF SHE WOULD TO TELL ME WHAT SHE AND RONNIE DID ON 090CT96, THE DAY PATRICIA DIED. HER DISCRIPTION OF THE DAY IS AS FOLLOWS.

KIM AND RONNIE GOT UP ABOUT THE SAME TIME AND RONNIE LEFT TO GO TO TEDS HOUSE AROUND 0730-0745 HRS. RONNIE WAS GOING TO TEDS TO BORROW HIS TRUCK TO HAUL UNDERPINNING FOR THEIR MOBILE HOME. RONNIE LEFT DRIVING KIMS 1992 CHEVROLET CAMERO GOING TO TEDS HOUSE. KIM LEFT DRIVING THIER WHITE DODGE DAYTONA GOING TO HER WORKPLACE AT PHYSICAL THERPY AND REHAB ON CYCH STREET IN GREENSBORO.

RONNIE CALLED KIM AT HER WORKPLACE AT 1200 NOON AND ASKED HER IF SHE WANTED HIM TO COME EAT LUNCH WITH HER AND SHE ASKED IF HE HAD GOTTEN THE UNDERPINNING AND HE SAID YES AND SHE TOLD HIM TO GO ON HOME AND START PUTTING THE UNDERPINNING ON THE MOBILE HOME. RONNIE TOLD HER THAT HE HAD TO GO GET THE CAMERO AT TEDS HOUSE AND LEAVE THE BOX TRUCK. KIM SAID THAT RONNIE WAS ALONE THAT DAY THAT SHE DIDN'T THINK ANYONE WAS WITH HIM THAT NONE OF HIS FRIENDS CAME HOME WITH HIM THAT WEEKEND FROM CAMP LEJUEINE. I ASKED HER WHO DID COME HOME WITH HIM OR WHAT THE FRIENDS NAME WAS THAT DID COME HOME WITH HIM ON WEEKENDS AND SHE SAID THAT IT WAS NEIL SILVERTHORN, A MARINE FRIEND.

SHE SAID THAT RONNIE TOOK THE BOX TRUCK TO TEDS HOUSE AND PICKED UP THE CAMERO AND DROVE BACK TO THEIR MOBILE HOME. RONNIE HAD ALREADY BEEN TO THE MOBILE HOME AND UNLOADED THE UNDERPINNING. RONNIE WORKED ON THE UNDERPINNING FOR A WHILE AND NEEDED A TOOL THAT HE DIDN'T HAVE AND GOT INTO THE CAMERO AND DROVE TO LYLES BUILDING MATERIALS TO BORROW IT FROM TED. WHEN HE GOT THERE TED WAS BUSY SO HE WAITED ON A CUSTOMER AND WAS THERE FOR A WHILE AND WHEN TED GOT FREE HE GOT THE TOOL AND DROVE BACK TO THEIR TRAILER ON MONNETT ROAD. SHE SAID THAT RONNIE CALLED HER BEFORE HE WENT TO LYLES AND TOLD HER THAT HE WAS GOING TO LYLES AND GET THE TOOL, THIS WAS ABOUT 1500 HRS.

KIM SAID THAT SHE GOT HOME AT 1740 HRS. SHE SAID THAT SHE WAS HUNGRY BUT TOLD RONNIE THAT SHE DIDN'T WANT TO COOK. RONNIE ASKED HER IF SHE WANTED TO GO OUT TO EAT AND SHE SAID THAT THEY COULD JUST GO TO THE WINN I IE AND GET SOMETHING AND BRING IT HOME AND EAT. THEY DROVE BY HER HOUSE AT 5313 COBLE CHURCH ROAD AND THEN TO THE WINN DIXIE WHERE TH. BOUGHT TWO STUFFED FLOUNDERS. THEY WENT HOME AND AT 2030 HRS WERE WATCHING TV AND EATING. THEY WENT TO BED AROUND 2100 HRS. AND SHORTLY

AFTERWARDS THEY RECEIVED A PHONE CALL AND THE PERSON CALLING HUNG UP. SHORTLY THE PHONE RANG AGAIN AND KIM ANSWERED IT AND A FEMALE WANTED RON AND EDNAS PHONE NUMBER, THIS IS RONNIES MOM AND DAD. RONNIE COMMENTED TO KIM THAT SOMETHING DIDN'T SEEM RIGHT AND WONDERED IF SOMETHING WAS WPONG IN THE CHURCH OR ONE OF THE PEOPLE IN THE CHURCH. THE CALLER

TIFIED HERSELF AS BEING KRISTY THE NEXT TIME SHE CALLED AND TOLD EM THAT TEDS HOUSE WAS ON FIRE. KRISTY SAID THAT TED WAS THERE BUT THAT THEY DIDN'T KNOW WHERE PATRICIA WAS. KIMBERLY CALLED HER MOTHER JUDY STUMP AND ASKED HER TO TRY TO CONTACT EDNA OR A CHURCH DECON AND LET THEM KNOW THE HOUSE WAS ON FIRE. THEY THEN DROVE TO TEDS HOUSE AND WAS STOPPED BY FIREMEN AND THEY TOLD THE FIREMEN THAT THEY WERE FAMILY. TED CAME TO THEM AND WAS CRYING AND HUGGED THEM AND SAID, I CAN'T UNDERSTAND WHATS GOING ON OR WHO DID THIS AND SAID HE HOPED PATRICIA WOULD PULL UP IN A CAR WITH A FRIEND. THEY LEFT SHORTLY AFTERWARDS AND DROVE TO HER MOTHERS HOUSE AND TOLD THEM WHAT THEY KNEW ABOUT THE FIRE AND LATER THE STUMPS AND KIM AND RONNIE DROVE TO SOUTH EAST BAPTIST CHURCH WHERE EVERYONE HAD GATHERED. THE PASTOR HAD TOLD THEM AT THE FIRE SCENE THAT THEY WERE MEETING AT THE CHURCH LATER ON THAT NIGHT.

I ASKED KIMBERLY IF ANYONE HAD TOLD HER NOT TO TALK TO ME OR ANY LAWENFOREMENT OFFICER AND SHE SAID THAT RON AND EDNA KIMBLE TOLD HER THAT IT PROBABLY WOULD BEST IF SHE DIDN'T TALK TO LAWENFORCEMENT.

SHE SAID THAT RONNIE WAS A VERY EMOTIONAL PERSON AND THAT SHE HAS SEEN HIM CRY ON MANY OCCASIONS AND SHE WOULD KIDD HIM AND TELL HIM THAT SHE MADE HIM CRY. SHE SAID THAT SHE COULD TELL WHEN RONNIE WAS TELLING A LIE THAT HE COULDN'T HIDE IT FROM HER, THAT IT SHOWED.

KIMBERLY ALSO SAID THAT SHE DIDN'T KNOW WHO KILLED PATRICIA BUT WHO EVER DID IT SHOULD GET THE DEATH PENALTY.
