RITA REFERRED TO HER APPOINTMENT BOOK, THE SAME BOOK SHE HAD MADE ME COPIES OF THE 040CT95 AND 050CT95 AND GAVE ME THIS STATEMENT.

ON 040CT95 SHE CALLED TED TO SET UP AN APPOINTMENT FOR TED AND PATRICIA. THIS CALL TOOK PLACE SOMETIME BETWEEN 1200 HRS AND 1459 HRS. THE 1500 HR. APPOINTMENT WAS SITTING IN HER OFFICE FOR THEIR APPOINTMENT ON TIME AND SHE HAD OTHER APPOINTMENTS UNTIL CLOSING TIME. RITA SAID SHE CALLED 294-0789 AND TED KIMBLE ANSWERED THE PHONE WHEN THIS APPOINTMENT WAS MADE. RITA THOUGHT THIS WAS TEDS RESIDENCE PHONE NUMBER UNTIL I INFORMED HER THAT IT WAS HIS PLACE OF BUSINESS.

ON 050CT95 TED AND PARTICIA DID NOT SHOW UP FOR THEIR 1130 HR.
APPOINTMENT AND RITA CALLED THE SAME NUMBER 294-0789 AGAIN AND TED
A' WERED THE PHONE AGAIN AND SHE MADE ANOTHER APPOINTMENT FOR 120CT95.
T. CALL TOOK PLACE SOMETIME BETWEEN 1400 HRS. AND 1600 HRS. AGAIN SHE HAL A PATIENT AT 1600 HRS. AND NO PHONE CALLS WERE MADE AFTER 1600 HRS.

ON 040CT95 TED WAS WORKING FIRST SHIFT AT PRECISION FABRIC CO. AND DID NOT GET OFF WORK UNTIL AFTER THE STATED TIME RITA CALLED HIM FOR THE APPOINTMENT.

ON 05OCT95 TED WAS AGAIN WORKING FIRST SHIFT AT PRECISION FABRIC CO. AND ACCORDING TO WORK RECORDS WORKED OVER THAT DAY UNTIL RITA HAD CLOSED PORTAMEDICS BUSINESS FOR THE DAY.

THESE TIME WOULD INDICATE THAT TED WAS ON THE CLOCK AT PRECISION FABRIC CO. AND HAD LEFT AND WAS AT LYLES AT THE TIME THE CALLS CAME FROM RITA ON 04OCT95 AND 05OCT95.

THIS WOULD FURTHER INDICATE THAT TED WOULD BE ABLE TO LEAVE PRECISION FABRIC CO. AND NO ONE KNOW THAT HE WAS GONE AND STILL BE ON THE CLOCK OR THAT HIS SUPERVISOR OR SOMEONE IN PRECISION FABRIC CO. KNEW HE WAS GONE AND COVERED FOR HIM.
