I CALLED THE EVIDENCE SECTION AND ADVISED OFFICER MCDANIEL TO GET ITEMS 49,51,52 AND 53 READY THAT TED KIMBLE AND MYSELF WOULD BE OVER SHORTLY TO PICK SAME UP THAT I WAS RELEASING SAME TO TED.

I WENT OUT AND GREETED TED AND WE WALKED OVER TO GREENE STREET TO OUR EVIDENCE SECTION. OFFICER MCDANIEL HAD THE ITEMS READY AND I SIGNED THE RELEASE AND TED SIGNED AS PICKING SAME UP. TED TOOK POSSESSION OF THE ITEMS AND WE WALKED BACK OVER TO SYCAMORE STREET. WHILE IN THE EVIDENCE ROOM TED ASKED ME IF WHEN HE COULD GET THE PURSE AND THE CREDIT CARDS AND I TOLD HIM THAT I COULD NOT RELEASE ANYTHING ELSE WITHOUT THE DISTRICT ATTORNEYS PERMISSION. I TOLD HIM THAT THE PURSE BELONGED TO PATRICIA AND THAT HE PROBABLY WOULD NOT GET IT UNTIL THE CASE WAS OVER AND THAT THE CREDIT CARDS COULD PROBABLY BE RELEASED BUT ONLY AFTER THE DISTRICT ATTORNEY SAID SO. I TOLD TED THAT I WOULD CONTACT THE DISTRICT ATTORNEY AND THAT I WOULD LET HIM KNOW.
