- 4. Narrative: THE FOLLOWING IS TEDS STATEMENTS TO ME ON THE NIGHT OF PATRICIAS DEATH. WE WERE AT SOUTH ELM BAPTIST CHURCH. DET.SGT. DeBERRY WAS PRESENT.

THEY FIRST MET ABOUT FIVE YEARS AGO, DATED FOR TWO YEARS BEFORE BEING MARRIED IN DANVILLE VIRGINIA ON 22DEC93. THEY HAD A BIG CHURCH WEDDING ON 07MAY94. DURING THE FIRST AND SECOND MARRIAGE PATRICIA WOULD STAY WITH HIM A LOT AT HIS PARTENTS HOUSE. SAID HE BOUGHT BUSINESS FROM GARY LYLES WHO NOW LIVES AT 26 N.E. LONGBEACH, N.C. 910-278-5707 AND HAD WORKED FOR HIM ABOUT TEN YEARS PRIOR TO BUYING. LEFT FOR WORK AT 0730 090CT95 AND PATRICIA WAS STILL IN BED. BROUGHT LUNCH TO THE BUSINESS 090CT95 AND THEY ATE TOGETHER. HIM SHE WAS GOING HOME AT 1530HRS. 090CT95 AND MOW THE GRASS. SAID THERE WAS A 5 GALLON CAN OF GASOLINE IN THE GARAGE AND A 2 GALLON CAN IN THE BUILDING BELOW THE HOUSE. TALKED TO HER BY PHONE AT 1530 HRS. 090CT95 AT HER WORKPLACE AND TOLD HIM AGAIN SHE WAS GOING HOME TO MOW THE GRASS. WENT TO SECOND JOB AND GOT THERE AT 1800 HRS. HAD KEPT HIS MOMS DOG ON 090CT95 AND HAD MET HER AND GIVE DOG TO HER AT 1745 HRS. HE) THAT PATRICIA WOULD PAGE HIM AND PUT 7'S IN IF ALL WAS OK, SHE LN'T BY 1830 HRS. HE PAGED HER AND DIDN'T GET A RETURN. CALLED REUBEN AND ASKED IF HE HAD TALKED TO HER AND HE HAD NOT. HUNG UP AND CALLED HOME, NO ANSWER, NO ANSWEREING MACHINE. CALLED RUEBEN BACK AND HAD HIM GO TO HIS HOUSE AND CHECK ON PATRICIA.
SAID INSURANCE ON HOUSE WAS WITH ACORDIA N.C. AND THEY ARE CANCELING NOW BECAUSE OF TOO MANY CLAIMS. CALLED STATE FARM TODAY BUT THEY WERE (COLUMBUS DAY) HAS AUTO POLICY WITH STATE FARM AND DISABILITY, CLOSED. LIFE INSURANCE WITH MASS MUTUAL, HARVEY APPLE AGENT AND GEORGIA LIFE TOOK POLICY ONE MONTH AGO. DIDN'T KNOW KNOW IF POLICY WAS IN EFFECT. THEY DECIDED TOGETHER THAT THEY NEEDED ADDITIONAL LIFE INSURANCE. SAID SOMEONE CALLED HIM AT WORK AND TOLD HIM HIS HOUSE WAS ON FIRE AND THINKS IT WAS RUEBENS WIFES MOTHER 6742706. SAID THEY WERE SUPPOSED TO GET A PSYSICAL 120CT95 FOR THE INSURANCE POLICY SAID HE HAD ONE TV AND WAS IN LIVING ROOM AND ONE VCR IN LIVING ROOM. SAID HE HAD THREE GUNS IN HIS BEDROOM UNDER THE BED A 300 WIN. MAG, 1100 REMINGTON AND A GLOCK .45CAL. HE SAID THAT PATRICIA WAS UPSET WITH THE \$200,000.00 LIFE INSURANCE POLICY AND THAT HE HAD CANCELED IT.

THIS WAS THE EXTENT OF WHAT TED TOLD ME THE NIGHT OF PATRICIAS DEATH.

TED SAID HE WAS COLD WHILE I WAS TALKING TO HIM AND I GOT A BLANKET FROM
