HE LOOKED IN THE MASTER BATHROOM AND SAW THE DEAD DOG AND SAID IT SCARED HIM WE WENT BACK INTO THE HALLWAY AND I ASKED HIM WHAT HE HAD LOST THAT HE TREASURED MOST AND HE THOUGHT FOR A WHILE AND I ASKED AGAIN WHAT MENT MOST TO HIM THAT HE LOST IN THE FIRE AND HE SAID, MY WIFE PHE NEVER ASKED ANYTHING ABOUT PATRICIA, WHERE SHE WAS FOUND OR HOW SHE MIGHT HAVE DIED WE STEPED OUT ON THE FRONT STOOP AND TED TOLD ME THAT I WAS THE ONE HE WAS LOOKING TO A FRIEND. HE SAID THAT IT REALLY BOTHERED HIM WHEN HE WAS ALONE AND IT HE WAS GLAD THAT HE DIDN'T HAVE TO LOOK AT HER IN A CASKET. LASKED HIM IF HE WAS GOING TO STAY WITH THE INSURANCE PEOPLE AT THE HOUSE THEN AND HE SAID, "NO", HE DIDN'T WANT ANYTHING ELSE TO DO WITH THE HOUSE, THAT EVERYTHING WAS GONE.
