HE STATED THAT HE ALWAYS BOUGHT A GUN PERMIT WHEN THE GUN SHOW WAS IN TOWN AND THAT HE THOUGHT HE HAD BOUGHT A .38 CAL AND A .32 CAL. AND HIS PARENTS HAS THEM NOW. HE ALSO TOLD ME THAT HE HAD PREVIOUSLY BOUGHT A .38 CAL PISTOL AT SPORTS UNLIMITED AND GAVE IT TO A FORMER GIRL FRIEND KIM PALMER. KIM GOES TO SOUTH ELM BAPTIST CHURCH ALSO. (((\*\*\* I SPOKE WITH KIM PALMER AT 852-3572 HOME, 230-8640 PAGER, AND SHE SAID THAT SHE DID DATE TED FOR ABOUT FOUR MONTHS BACK IN 1992 IN THE WINTER MONTHS. SHE SAID THAT HE WAS BACK AND FORTH WITH PATRICIA AND HER COUSIN AND THAT SHE HAD SPOKEN TO PATRICIA AND HAD TOLD HER THAT SHE DIDN'T WANT TO GET INTO THE TRIANGLE AND COULD SEE THAT HE LIKED PATRICIA AND HER COUSIN MORE THAN HER, SO SHE JUST DRIFTED OUT OF THE PICTURE. \*\*\*)))... TED BECAME SOMEWHAT UPSET WITH ME ASKING ME ABOUT THE GUNS AND WANTED TO KNOW WHAT IT HAD TO DO WITH HIS WIFES DEATH. I EXPLAINED THAT I NEEDED TO KNOW EVERYONE HE HAD COME IN CONTACT WITH THAT MIGHT HAVE ANYTHING AGAINST PATRICIA FOR ANY REASON.
- CALLED ME BACK APPROXIMATELY THIRTY MINUTES LATER AND HIS FIRST STION WAS "IS THERE ANYTHING ELSE YOU WANT TO ASK ME". I WAS NOT EXPECTING THE CALL OR A QUESTION LIKE THIS SO I ASKED HIM WHAT HE WAS TALKING ABOUT. HE SAID THAT HE HAD TALKED TO HIS ATTORNEY MR BOUDEN AND HIS ATTORNEY TOLD HIM TO NOT TALK TO ME UNLESS HE WAS PRESENT, THAT IN LEGAL TERMS I MIGHT BE TRYING TO GET ENOUGH EVIDENCE AGAINST HIM TO CHARGE HIM WITH HIS WIFES DEATH. TED USED THE WORD ENTRAPPED AND I TOLD HIM TO TELL HIS ATTORNEY THAT THERE WAS NO WAY I WAS TRYING TO TRAP ANYONE THAT I WAS AFTER THE FACTS AND THAT I INTENDED TO GET THEM TO FIND OUT WHO KILLED HIS WIFE.
