- Narrative: TED KIMBLE CALLED THIS WRITER BY PAGER AT APPROXIMATELY 2215 HRS. ON 11-01-95 AND I RETURNED HIS CALL AT 685-0705. TED WANTED ME TO KNOW THAT HE DID GO TO SPRINKLES GAS AND PAY FOR THE GAS THAT HIS BROTHER HAD GOT IN HIS BOX TRUCK ON OCTOBER 9TH WHEN HE HAD BORROWED IT TO GET UNDERPINNING FOR HIS, RONNIES, MOBILE HOME. TED SAID HE DIDN'T WANT ME TO THINK HE WAS LYING AND KEEPING ANYTHING FROM ME THAT HE HAD JUST FORGOT ABOUT RONNIE COMMING BY AND TELLING HIM ABOUT GETTING THE GAS AND CHARGING IT TO HIS COMPANY. TED SAID THAT HE HAD TALKED TO HIS BROTHER RONNIE BY PHONE AT CAMP LEJEUNE THAT MORNING. THIS IS TWO DAYS AFTER NCI INVESTIGATOR G. GREGORY MUNROE INTERVIEWED RONNIE KIMBLE AT CAMP LEJEUNE, MCB. TED TOLD ME TWICE THAT THERE WAS NO WAY HIS BROTHER COULD HAVE KILLED HIS WIFE. I ASKED TED AGAIN AS I HAD ASKED BEFORE WHY HE DID NOT INFORM ME THAT HIS BROTHER WAS HERE IN GUILFORD COUNTY ON 090CT95 AND IN FACT AT HIS AND PATRICIAS HOME THAT DAY. I ALSO TOLD TED THAT AT THIS POINT IN THE INVESTIGATION THAT RONNIE WAS THE LAST KNOWN PERSON AT HIS AND HIS WIFES RESIDENCE BEFORE SHE WAS MURDERED. AGAIN I TOLD TED THAT IF HE DIDN'T HAVE ANYTHING TO DO WITH KILLING HIS E THAT HE HAD NOTHING TO WORRY ABOUT.

SAID HE WANTED TO HELP ME BUT HE WAS AFRAID HE WOULD DO OR SAY THE WRONG THING AND I WOULD THINK HE WAS LYING AND TRYING TO KEEP SOMETHING FROM ME. I TOLD TED THAT ALL I WANTED WAS THE TRUTH FROM HIM AND FOR HIM NOT TO KEEP ANYTHING FROM ME LIKE HIS BROTHER BEING IN GUILFORD COUNTY THE DAY PATRICIA WAS MURDERED. TED ALSO SAID THAT HE KNEW HIS BROTHER HAD NOTHING TO DO WITH PATRICIAS MURDER AND THATS WHY HE DID NOT BOTHER TO TELL ME RONNIE WAS IN GUILFORD COUNTY THAT DAY. I REASURED TED AGAIN THAT HE COULD CALL ME ANYTIME AND THAT I WAS GOING TO FIND OUT WHO KILLED HIS WIFE AND THAT IF DIDN'T HAVE ANYTHING TO DO WITH HER DEATH THAT HE DIDN'T HAVE ANYTHING TO WORRY ABOUT.
