. Narrative: ON 31MAY96 I WENT BY 304 LOWDERMILK STREET, THE ESIDENCE OF RODNEY WOODBERRYS MOTHER TO PICK HIM UP FOR A POLYGRAPH EST AT THE SBI OFFICE. RODNEY WAS WAITING WITH BEVERLY AND ASKED IF IT AS ALRIGHT IF SHE WENT ALONG AND HE RODE WITH HER AND FOLLOWED ME. I OLD HIM THAT IT WAS ALRIGHT BUT THAT BEVERLY WOULD HAVE TO WAIT IN THE OBBY OF THE SBI OFFICE. THEY FOLLOWED ME TO THE SBI OFFICE AND BEVERLY AITED IN THE LOBBY WITH RODNEY WHILE I SPOKE TO AGENT DAVE HEDGECOCK ND AGENT PENDERGRASS.

ODNEY WAS GIVEN A POLYGRAPH TEST BY AGENT HEDGECOCK AND AFTER THE TEST GENT HEDGECOCK CAME OUT AND INFORMED AGENT PENDERGRASS, SGT. DeBERRY ND MYSELF OF THE RESULTS OF THE TEST.

GENT HEDGECOCK WENT BACK IN AND INTERVIEWED HIM AS TO HIS KNOWLEDGE OF HE MURDER AND HE SAID HE HAD NO KNOWLEDGE OF PATRICIAS MURDER, AND HAT HE WAS IN BURLINGTON THE DAY SHE WAS MURDERED.

GENT HEDGECOCK CAME OUT AGAIN AND INFORMED US OF WHAT RODNEY HAD SAID ND LSO WENT BACK IN A SECOND TIME AND SPOKE WITH RODNEY GETTING THE A ANSWERS AS BEFORE BUT ADDING THAT HE REMEMBERED TED TELLING HIM AS SUMMER THAT HE WISHED HE HAD A HIT MAN.

JENT PENDERGRASS AND MYSELF HAD RODNEY WALK TO PENDERGRASSES OFFICE HERE WE INTERVIEWED RODNEY AGAIN. RODNEY WAS OFFERED SOMETHING TO RINK AND A SNACK FROM THE BREAKROOM AT THE SBI OFFICE AND HE ONLY ANTED SOME COFFEE D A POT OF COFFEE WAS MADE AND RODNEY GOT A CUP. DDNEY DID NOT CHANGE HIS STORY DURING THIS INTERVIEW IN PENDERGRASSES FFICE. HE STATED THAT HE HAD NOTHING TO DO WITH PATRICIAS DEATH AND DULD COOPERATE IN ANYWAY TO CLEAR HIMSELF. I ASKED RODNEY TO CALL TED IMBLE BY PHONE FROM THE OFFICE AND ASK HIM ABOUT THE THINGS TED HAD DLD HIM LAST SUMMER AND LAST JANUARY. RODNEY WAS RELUCTANT AT FIRST JT DID DECIDE TO MAKE THE CALL.

DDNEY CALLED LYLES BUILDING MATERIALS FROM THE SBI OFFICE BUT TED WAS DT THERE AND WAS TOLD THAT TED WOULD BE BACK IN ABOUT 45 MINUTES. IRING THIS 45 MINUTES RODNEY TALKED TO BEVERLY OUTSIDE IN THE PARKING DT AND ALSO RODE WITH ME TO MCDONALDS IN GUILFORD COLLEGE. I OFFERD BUY RODNEY SOMETHING TO EAT BUT HE ONLY WANTED A SOFTDRINK, A SPRITE, LICH I BOUGHT FOR HIM.

DROVE BACK TO THE SBI OFFICE AND RODNEY MADE A SECOND CALL TO LYLES ID TED KIMBLE ANSWERED THE PHONE. RODNEY MENTIONED THE FACT THAT THE WAS TALKING TO HIM ABOUT THE DEATH OF PATRICIA AND BROUGHT UP THE CT ABOUT TED TELLING HIM ABOUT THE HIT MAN, ABOUT WISHING SHE WAS DEAD ID THE MONEY AND ABOUT HER BEING OUT OF HER MISERY. TED DENIED EY THING AND TOLD RODNEY THAT HE NEVER TOLD HIM ANY SUCH THING. TED Labeled Conney That HE KNEW WE WERE TAPING THE CONVERSATION AND THAT HE SI ANTED EVERYONE TO KNOW THAT HE LOVED HIS WIFE AND MISSED HER AND SHED HE COULD HAVE HER BACK. HE ADVISED RODNEY TO CONTACT HIS

IS ONLY A PART OF THE CONVERSATION. THE ENTIRE CONVERSATION IS ON

EXPLAINED TO RODNEY THAT THIS LOOKED GOOD FOR HIM AT THIS POINT, BUT THAT I WOULD MORE THAN LIKELY WANT TO TALK TO HIM AGAIN IN AN ATTEMPT LEAR HIM OF THE DEATH OF PATRICIA. I EXPLAINED TO RODNEY THAT I WAS OT TRYING TO TRAP HIM IN ANY WAY THAT I WAS ONLY TRYING TO CLEAR HIM 'ROM THIS CASE AND THAT I APPRECIATED HIS HELP AND COOPERATION IN THE 'ASE.

CODNEY LEFT WITH BEVERLY AND I TOLD HIM THAT I WOULD BE IN TOUCH WITH IIM ON MONDAY 03JUNE96.
