then you swore everything in that affidavit was true

among other things you swore the following was true:

but after giving that statement you agreed to make a taped
call to ted for detective church

and you tried to get ted to admit that he said the things
you are now claiming he said
he denied all that said he didn't know what you were talking
about
you talked to church and pendergrass abt. what to say to ted
to get him to trust you
that they were trying to put this thing on you

in your affidavit you signed you made it point to write out
in your own handwriting that on the day patricia died you
were at your house in graham
and you also wrote out in your handwriting that at 6:30
p.m. you went to fill out a job application

did you have something to do with patricia's death
do you know a woman by the name of laura shepard
do you remember telling her on april 5, 96 when she came
into the room after you woke her up because you were crying
and when she asked you why you were crying you asked her to
promise that she would come to visit you in prison
that you told her you had done something that could get you
the death penalty
then you told her that you would be coming into some money
soon and you would provide her with money while you were in
prison
